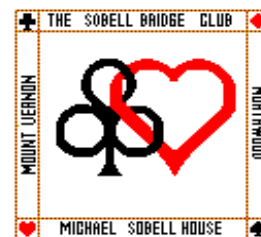

1 The minutes of the previous meeting, no. 85, held on 25<sup>th</sup> January, 2014 were approved.

### 2 Matters arising:

- iv) DE expressed view that there is now no need for an Almoner because hospitals no longer take flowers. DE has been writing letters/cards on behalf of the club.
- v) Proposed table money increase to £4.00 was discussed again. A motion will be proposed at AGM so that members can decide. Rationale will be explained to members by Directors i.e. to increase income for Hospice **Directors**
- ### 3 Chairman's report
- i) Disciplinary issues were discussed. GH asked that 'Behaviour at Bridge Table' cards could be displayed on tables by Directors. **Directors**
- ii) Six new bridge tables will be bought and smaller tables will be discarded **DE**

- vi) Net surplus is up by 11.35% to £35,517.99
- vi) A total of £33,000 will have been donated to Friends this year.
